Short-term LDC Changes

For what seems like years (and probably has been!) the City has been addressing concerns from the public regarding the issue of short-term rentals and the effects on our residential areas. These concerns have grown new legs the past year or so with the influx of build-to-rent homes of hotel proportions. There have been many of these homes under development and many more in the planning phases with nine bedrooms or more.

Considering the problems many of our residential areas south of 98 are already facing, these new and certainly not single-family homes are already significantly adding to the existing issues such as parking and noise. One new "single-family" home is 9,000 square feet, 9 bedrooms– yet an ad in Saturday's *Destin Log* notes it is 'expected to gross more than \$700,000 in first-year rental vacation income."

I have been vocal in my desire to ensure that these mini-hotels do not negatively impact our residents, community, and quality of life. Staff has pulled together a few ways we can minimize their impact to neighboring homes and community. These ideas will be presented to council at our meeting on Monday, November 7th. Among the items being considered: mandatory green space of 30%, one parking space per bedroom, and a maximum height of 35'. These changes are proposed for Crystal Beach and Holiday Isle. I encourage you to attend and/or weigh-in. Do you agree with these proposed changes? I look forward to hearing from you!





Would you like to be a part of reviewing the Destin City Charter? During the City's Strategic Visioning Session on May 3, 2016, the City Council determined that the City Charter presently contains provisions that would benefit from review. The review of the City Charter is one of Council's top priority objectives for FY 2017. Over the years, many citizens have pointed out items that should be in our charter and aren't, and there have been many times at city council that we have sought some direction only to be told the charter didn't address that particular issue. Well, it is time for an update.

On Monday, the Council will discuss the way forward, but here is the tentative plan: A Charter Review Committee be formed with each Council member nominating a person for appointment to the Committee. The Committee will conduct a comprehensive review of the current City Charter and propose an amendment for approval consideration by the City Council.

Concrete Plant Purchase



One of the council's goals has been acquiring more waterfront property to provide public parks for all to enjoy. We are thrilled to announce the acquisition of the old concrete plant on Joe's Bayou in a purchase completed last week. The city paid \$2M for the almost four-acre park on Beach Street, and is already in talks with the Tourist Development Council on funding and grant opportunities. The plant will be developed into a waterfront park with 1600 feet of shoreline. The

city is seeking input and ideas on how best to develop and build a park for all to enjoy. One suggestion has been to make it pet-friendly, which I think is an excellent idea given the popularity of our dog park! (By the way, if you haven't seen the new paw patio you need to stop by!) I am excited about the possibilities for this park and seeing it come to fruition – along

with the others parks we have in the planning stages. I see these efforts as one way to give back to the community and provide for our residents.

Norriego Point Restoration and Recreation Project Public Meeting The Florida Department of Environmental Protection (DEP), along with the City of

Destin, will host an informational meeting on the Deepwater Horizon Natural Resource Damage Assessment Phase III Early Restoration Project, Norriego Point Restoration and Recreation Project, at the Destin Community Center (101 Stahlman Ave) on Tuesday, November 15, 2016, from 5:30-7:30 p.m. DEP staff and representatives from Taylor Engineering, Inc., the project design consultant, will be available at the informational meeting to answer questions and provide additional details on the project.

Medical Marijuana Zoning The Zoning for Medical Marijuana dispensaries will be discussed on Monday, the 7th. Current proposed location is the industrial area of Town Center with a setback of 300'.

BI Inc. and Dewey Destin's Harborside v. City of Destin The City has been served with a lawsuit regarding the fencing off of the easement/

driveway on the west side of the property. Because this is in litigation I cannot comment on it but I encourage you to review past city council meeting minutes where the issue was discussed.
